Explore Burnaby Trick or Treat Contest

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Explore Burnaby Trick or Treat Contest (the "Promotion") is open only to legal residents of Canada who are at least eighteen (18) years old at the time of entry and who did not purchase any equipment for purposes of entering the Promotion. Employees of Tourism Burnaby and any of their respective related companies, parents, subsidiaries, affiliates, and agents and any agencies or other companies involved in the development or execution of the Promotion or production or distribution of promotional materials, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee, are not eligible.

3. 4. Timing: The Promotion begins on October 13, 2020 at 12:00 a.m. Pacific Time ("PT") and ends on October 31, 2020 at 11:59 a.m. Pacific Time ("PT") (the "Promotion Period").

The Administrator's computer is the official time-keeping device for the Promotion.

5. How to Enter:

For entrance into the grand prize, submit an image taken and one of the thirteen Contest stops to the entrant portal on www.tourismburnaby.com/halloween. Participants may enter for each location once but may enter for as many of the thirteen locations as they choose.

For the bonus contest, share an image or video at one of the contests stops. Tag the Photo with #BOOrnaby in the caption after uploading publicly to your Twitter or Instagram account, during the promotion timing period.

Photo Guidelines:

The Photo must contain a caption and description which includes where the Photo was taken;

The Submission's caption and description must be in English;

The Photo cannot have been submitted previously in a promotion of any kind or exhibited or displayed publicly through any means.

Content Restrictions:

The Photo must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright infringement;

The Photo must not contain brand names or trademarks,

The Photo must not contain material that is inappropriate, indecent, obscene hateful, tortious, defamatory, slanderous, or libelous.

The Photo must not contain material that promotes bigotry, racism, hatred, or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; and

The Photo must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any state where the Photo is created.

For all Photos: Uploading a Photo constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display such submissions in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes. If necessary, entrant will sign any necessary documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting to use the Photo. Sponsor is not responsible for lost, late, incomplete, invalid, un-intelligible or misdirected Photos, which are disqualified. Limit: Each entrant may upload eight (8) Submissions during the Submission Phase. Entrant may receive one (1) entry per Submission during the Contest. Entrants must have permission from all individuals that appear in a Submission (if any) to use their name and likeness in the Submission and to grant the rights set forth herein. If requested, entrant must be able to provide such permissions in a form acceptable to Sponsor. Uploading a Submission constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display such Submission in whole or in part, on worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including or promotional or marketing purposes. Released Parties (as defined in Section 10, below) are not responsible for lost, late, stolen, damaged, incomplete, invalid, un-intelligible, garbled, delayed, or misdirected entries/Submissions, which will be disqualified. In the event of a dispute as to any entry/ Submission, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being an authorized account holder.

6. Winner Determination: Winners will be determined via the processes set forth below.

Administrator will randomly select the potential prize winner from all eligible entries received on or around contest draw date. Potential winners will be contacted on through email after the date of the applicable drawing.

Administrator will randomly select the potential prize winner from all eligible entries received on or around contest draw dates outlined in prize table for the bonus contest. Potential winners will be contacted on through direct message after the date of the applicable drawing.

7. Winner Requirements: Receiving a prize is contingent upon compliance with these Official Rules. If a potential winner cannot be contacted, fails to execute and return the Declaration of Compliance, Liability and Publicity Release within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits the prize. In the event that a potential Contest winner is disqualified for any reason, an alternate winner will be determined by another random selection. If after three (3) attempts a Contest winner is not confirmed, the applicable prize will remain un-awarded. Sponsor shall not incur any liability whatsoever to the extent Sponsor chooses to refrain from any exploitation of its rights hereunder. Winner will indemnify Sponsor, Released Parties (as defined in Section 9, below) and any licensee of Sponsor against all claims, damages, liabilities, and expenses (including reasonable counsel fees and legal expenses) arising out of any breach of these terms. Prizes will be fulfilled 8 – 10 weeks or earlier after end of Contest.
